City of DuPont Municipal Code (DMC) 5.04.170 requires the owners of any residential property located in DuPont and which is leased or rented to residential tenants to obtain a City of DuPont Rental Housing Business License. Licenses are due upon the first month of rental use and renewals are due January 1st of each year and is current if paid by January 31st. The license fee is determined by the number of rental units you own in DuPont, per the following schedule.

- 1 Unit \$75.00 per year
- 2 to 4 Units \$100.00 per year
- 5 to 24 Units \$200.00 per year
- 25 or more Units \$1,000.00 per year
