In accordance with DMC 25.175.010(3)(c), your application is now complete for processing as the submission materials are sufficiently complete for review. As described in our letter dated June 28, 2021, we will proceed processing your application with the understanding that the screening of incompatible uses will be evaluated as part of the SEPA process and may eventually require that a landscape plan for the perimeter buffers be provided.

The City will be issuing a Notice of Application on August 30, 2021. The site will need to be posted with three public notice boards by that date. The notice boards can be picked up at City Hall. Please contact me or Janet Howald ([jhowald@cityofdupontwa.gov](mailto:jhowald@cityofdupontwa.gov)) at the City to arrange for the pickup.

The notice boards should be installed five feet from your property line at the following three locations:
