

**CITY OF DUPONT  
STATE ENVIRONMENTAL POLICY ACT (SEPA)  
DETERMINATION OF SIGNIFICANCE (DS)  
And Request for Comments on the Scope of the  
Environmental Impact Statement (EIS) for  
Pioneer Aggregates South Parcel Project**

**Proponent:** Glacier Northwest Inc. dba CalPortland, 4301 Pioneer Avel, DuPont, WA 98327 and 3450 S. 344<sup>th</sup> Way Suite #201, Federal Way, WA 98001

**Location of Proposal:** The proposed South Parcel Project site is located to the southeast of the existing Pioneer Aggregates Mine in the City of DuPont in southwestern Pierce County. The site is located within the City's designated Mineral Resource Overlay and is bordered to the north and west by the existing Pioneer Aggregates mine; to the east by industrial/distribution facilities including Amazon, Dania, Pier 1 Imports, and FedEx; and to the south by Sequelitchew Creek and the Creekside Village residential development. The South Parcel Project would occur on lands owned by Weyerhaeuser Company and leased to CalPortland.

**Background Information:** CalPortland's original sand and gravel mine ("Existing Mine") was permitted in 1997 (355 acres). An EIS and Supplemental EIS were prepared for that proposal, which included construction of a dock at Tatsolo Point for shipment of mined material by barge. In 2006, the City amended its Comprehensive Plan to revise its overall land use plan to expand the City's Mineral Resource Overlay. The expanded Mineral Resource Overlay includes an approximately 200-acre area leased by CalPortland southeast of the Existing Mine ("South Parcel") and an approximately 201-acre area located north of the existing mine ("North Parcel"). After the City issued a Supplemental EIS (SEIS) for the South Parcel in 2007, CalPortland submitted permit applications to mine the South Parcel. In 2009, a group of environmental and conservation organizations formally disputed the South Parcel activities and mitigation measures proposed at the time. This dispute process resulted in the *2011 Settlement Agreement for DuPont Mine, Restoration of Sequelitchew Creek Watershed, and Preservation of Puget Sound Shorelands and Adjacent Open Space* (2011 Settlement Agreement) that set forth a process for the submittal and review of permit applications (including SEPA review) for the North Parcel first and then the South Parcel. The Settlement Agreement was signed by a contingent of stakeholders, referred to as the environmental caucus, which consists of CalPortland, City of DuPont, Washington State Department of Ecology, Nisqually Delta Association, Washington Environmental Council, People for Puget Sound, Black Hills Audubon Society, Tahoma Audubon Society, Seattle Audubon Society, and the Anderson Island Quality of Life Committee. The Settlement Agreement also prescribed the process for the development, funding, and implementation of a Sequelitchew Creek Restoration Plan to help restore and enhance the Sequelitchew Creek watershed, including flows along the length of the Sequelitchew Creek. As provided for in the 2011 Settlement Agreement, in 2013 CalPortland applied for permits to allow mining within the North Parcel. Following publication of a Final EIS ("North Parcel EIS") in 2013, the North Parcel mining expansion was permitted in 2014. The North Parcel EIS contemplated mining the South Parcel as an independent but related proposal and evaluated the cumulative impacts of mining both the North and South Parcels. In May 2021, CalPortland applied for permits to allow mining within the South Parcel, as described below.

**Description of the Proposal:** The proposed South Parcel mining project includes horizontal expansion of mining into approximately 188 acres previously undisturbed by mining, and vertical expansion of approximately 125 acres where re-mining will deepen a portion of the existing Pioneer Aggregates mine. In advance of the mining, the project proposes to install wells to intercept and pump groundwater to dry out gravels for mining. The intercepted groundwater would be reinfiltated on the floor of the existing mine. The South Parcel Project is anticipated to extend mining at the current rate for approximately 14 additional years.

**Lead Agency:** City of DuPont

**EIS Required:** The City of DuPont, as SEPA lead agency, has determined that this project may have a significant adverse impacts on the environment, and that an Environmental Impact Statement (EIS) should be prepared, consistent with RCW 43.21C.030 (2)(c). The EIS will address probable significant adverse environmental impacts of the proposed South Parcel Project and will build upon the information and analysis in other environmental review for the mines, including the 1992 *Pioneer Aggregates Mining Facility and*

Reclamation Plan EIS, 2006/2007 Glacier Northwest Dupont Mining Area Expansion and North Sequelichew Resoration Project SEIS, and the 2013 CalPortland DuPont North Parcel Mining EIS.

**EIS Issues:** The City has preliminarily determined that the following elements of the environment will be included in the *Pioneer Aggregates South Parcel Project EIS*:

- **Earth**
- **Air Quality**
- **Surface Water and Groundwater**
- **Fisheries**
- **Plants and Animals**
- **Noise**
- **Land and Shoreline Use**
- **Aesthetics**
- **Cultural Resources**
- **Transportation**

**EIS Alternatives:** The Alternatives that have preliminarily been identified for analysis in the *Pioneer Aggregates South Parcel Project EIS* include:

- **Alternative 1 – No Action Alternative** – Assumes no mining on the South Parcel within the context of existing conditions.
- **Alternative 2 – Proposed South Parcel Project (With Restored Sequelichew Creek)** – Implementation of proposed South Parcel Project within the context of creek restoration.

**Scoping:** Agencies, affected tribes, and members of the public are invited to comment on the scope of the EIS, including alternatives, probable significant adverse impacts, mitigation measures, and licenses or other approvals that may be required.

**30-day public comment period:** The EIS scoping will provide opportunities for the agencies/tribes/public to provide input to the environmental review process. **All comments are due no later than 5:00 PM, October 20, 2021.**
