The Department of Ecology has reviewed the above referenced Conditional Use permit to authorize construction of a barge transshipment facility. This facility will include a pier, access road and gravel conveyor, to support an upland gravel mine, at Tatsolo Point on Puget Sound.

We concur that the proposal, as conditioned by the City, meets the intent of the master program and the criteria set forth in WAC 173-14-140 for granting a Conditional Use permit. The permit is hereby approved.
